2.	MINUTES & MATTERS ARISING		
	The minutes of the meeting held on 11 October 2012 were proposed by Peter Nightingale

3.	PARISH COUNCIL ISSUES		
	 RX1: the PC agreed to go ahead with the RX1 and CS will liaise with JB when he returns from his holiday. Action: JB & CS 		
	 CS reported that an individual has offered to buy/donate a tree for the jubilee and 		
	agreed to find out more before we make a decision. Action CS		
	 The fee for clearing the ditch between Priory Playing Field and the Football Field was discussed and it was agreed that CS would progress this with the Parish Council. Action: CS 		
	 It was noted that a copy of the approved minutes of these meetings should be forwarded to the parish clerk. Action: LR 		
	 Hay Crop: The hay was not bailed because the weather conditions were unsuitable and the hay was considered to be still too wet for bailing on the appointed day. Instead, it is intended that the hay be flailed on 3 fields (not on the water meadows). The most appropriate time for this is when we have a frost.

5.	Working Parties		
	Various jobs have been done in line with the maintenance plans. It is anticipated that the new memorial tree will be planted in December, possibly the 8 th or 9 th and also that the hedging would be planted at the top end of the memorial field.		
	The benches that have graffiti on them will be re-stained – Ian has some 'Red Cedar' stain but CS suggested we could borrow the actual stain from Roy.		
6.	Publicity		
	Brown Sign: It was reported that we are not eligible for a brown sign because they are not erected for monument's, therefore, this option is closed. It was suggested that perhaps we could look at changing the existing sign, which is provided by highways department. Christmas Cards: These are in progress. Julie will produce 12 and will liaise with IR to confirm recipients. Also, to include MAHG.

7.	Field Projects				
/.	Field Projects Orchard: PN reported that he would like to plant some older, more traditional varieties of				
	Orchard: PN reported that he would like to plant some older, more traditional varieties of				
	fruit tree and is liaising with a person at Hyde Hall. The ground needs to be cleared of nettles; mowed in the summer with a view to planting next autumn. The trees would				
	probably be half standards because they would be easier to mow under.				
	Arch Hedging: hedging plants are on order for December.				
	Colour: It is intended to plant bluebells around and between the fruit trees but this cannot				
	be done until the trees have been planted so probably for spring 2014. IR suggested planting				
	some bluebells in the memorial field this year.				
	Nest Boxes: The cubs are making 27 nest boxes (6 for bats; 6 are open fronted; and the				
	remainder are conventional). The girl guides and brownies are also interested so we will try				
	and involve them in this project this time next year. In the meantime PN will renew his				
	dormouse licence and then we can possibly produce some dormouse boxes. Several ideas				
	for other boxes we might provide were put forward such as tawny owl, kestrel, bug boxes				
	etc. The guides and brownies might be interested in producing one or more of these types.				
	There was also talk of reintroducing hedgehogs and PN will contact Tiggywinkles about this.				
	Night Time Stroll: It was suggested that a night time stroll might be organised for anyone				
	who wants to come along to see whatever can be seen at night time. Perhaps this could				
	happen next year in the springtime. Could school kids be included?
